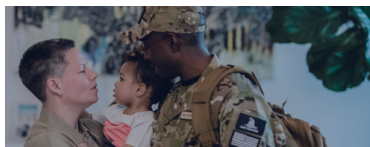
CURRENT MILITARY ADVOCACY CAMPAIGNS



H.R. 5979 and S.3068:

The VA Home Loan Awareness Act

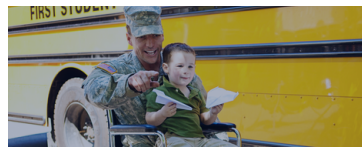
The VA Home Loan Awareness Act increases VA loan utilization by modifying mortgage applications with mandatory disclosures to those who qualify for a VA Home Loan.



H.R. 4335 and S. 2496:

The VALID Act

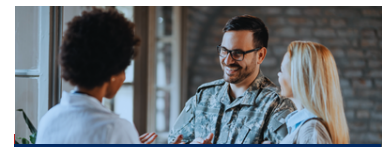
The VALID Act increases VA loan utilization by providing Veteran homebuyers with side-by-side comparisons of conventional, FHA, and VA home loans.



H.R. 6193:

The VALOR Act

The VALOR Act supports Disabled Veterans by extending VA exemptions to those who have completed their pre-discharge disability exams, pending their formal rating.



STATE LEVEL:

The Disabled Veteran Tax Exemption

Passed in California, Maryland, Utah, Florida, and Virginia, introduced in Michigan, North Carolina, and Illinois. Grants Disabled Veterans homebuying power, at zero cost to the state.
